2. The issue of Indian seafarers on board M.V. AFEL- 1 and Tanvana who are stranded in Busher Islands in Iran and all crew onboard vessels suffer with lack of drinking water, food and non payment of wages. The said seafarers were engaged by Recruitment and Placement Service, Mumbai .
