Also, we have deputed Dr. Senthil Nathan, PHO, Kandla for the inspection of Community Health Centre Diu, Ghoghla to assess the feasibility for opening of Yellow fever vaccination Centre.

It is mentioned that, community Health Centre, Moti Daman inspection has been carried out recently & we have requested DHS, Daman & Diu to depute the medical & paramedical staff for 2 days training at APHO, Mumbai
